Please send three 4 x 6 photographs of your craft product (digital copies are OK). Even though we do not jury crafters, we do want to ensure that we have a good mix of products for our customers. **After you have been approved, you will need to send a check for \$10 made payable to Western Youth Network to Punkin Festival, c/o Mast General Store, Highway 194, Valle Crucis, NC 28691 to hold your spot. This is non-refundable and can be deducted from your 10% donation on festival day. As a prior exhibitor, you get first chance to reserve your space. Applications are due by OCTOBER 1, 2009.**

Craft vendors are expected to provide their own 10 x 10 tents/canopy, tables, chairs, etc. Tents should be FLAME RETARDANT, with that fact stated on the tent and papers from the box that confirms this fact. The fire marshal may want to see this documentation. Tents must be secured in case of strong winds, but guy wires are not permitted.

ALL items must be handcrafted or homemade. NO manufactured clothing, toys, products are allowed.

Each vendor is required to donate 10% of their GROSS SALES at the end of the day to the Western Youth Network. You will be issued an envelope to use for your donation. A festival volunteer will come by at the end of the day to pick up your envelope.

MOVE IN/SET UP: Vendors may have vehicular access to the grounds until 9:45 a.m. on festival day. All cars must be moved to off-site parking after that time. All booths should be set up and ready for visitors no later than 10 a.m. The festival officially begins at 11 a.m. and runs until 4 p.m. Vehicles will not be allowed on festival grounds until after 4 p.m. except as deemed necessary by festival staff.

WAIVER: I agree to hold the Mast General Store, Western Youth Network, and the Valle Crucis Punkin Festival harmless for any loss or damage of personal property due to fire, accident or any other cause. The Mast General Store, Western Youth Network, and the Valle Crucis Punkin Festival shall not be liable to Vendor, Vendor's employees, agents, guests or others for personal injury resulting in any way from the Punkin Festival. Vendor expressly agrees to save, indemnify and hold harmless the Mast General Store and Western Youth Network, its members, officers, directors, agents and employees from any damages, charges, liabilities, claims and causes of action whatsoever which result from any act or failure to act. The Mast General Store and Western Youth Network make no representations, warranties or guarantees of any kind with respect to results obtained by Vendors as a consequence of participation in the Craft Show. Fees are not refundable for any reason, including cancellation of the event due to weather conditions or other circumstances beyond our control. I agree to the release of photographs for the promotion of Mast General Store, Inc., Western Youth Network, and/or the Valle Crucis Punkin Festival.
